#### I hereby declare that:

  - b. My Candidate's Statement duly signed by me
4. I have read and agree to comply with the Clause 66 of SLOBA article regarding the Alumni Manager Election and faithfully serve as the Alumni Manager for the full length of the term if so elected as a nominee.
5. I declare and confirm that presently and, if elected, my proposed nomination to the IMC for registration as an alumni manager of the IMC of St. Louis School does not infringe Section 40AL(5) of the Ordinance [serving the IMC in more than one capacity], Section 40AP(6) of the Ordinance [not a teacher of the School] and I meet all the registration requirements of an alumni manager in that none of the grounds of refusal under s30 of the Ordinance applies to me or would apply to me for the full term of office as such alumni manager if so elected and registered.
6. I shall not put myself in a position where my personal interest would conflict with that of St. Louis School and its student, and when such a conflict arises, I will put the interest of St. Louis School and its students over and above mine. In particular, I shall not directly or indirectly, whether by my partners, business associates, agents, employees or other officers, exploit the history and good name of St. Louis School for commercial or business interest.
7. I have read Section 30 of the Ordinance set out below:  
The Permanent Secretary may refuse to register an applicant as a manager of a school if it appears to the Permanent Secretary that —
  - the applicant is not resident in Hong Kong for at least 9 months in each year;
  - the applicant is not a fit and proper person to be a manager;
  - the applicant is a person in respect of whom a permit to teach has previously been cancelled;
  - the applicant is under the age of 18 years;
  - the applicant has attained the age of 70 years and he fails to produce a valid medical certificate certifying that he is physically fit to perform the functions of a manager;

- the applicant is under the age of 70 years and he fails to produce, upon a request by the Permanent Secretary, a valid medical certificate certifying that he is physically fit to perform the functions of a manager;
- in making or in connection with any application —
  - (i) for registration of a school;
  - (ii) for registration as a manager or a teacher; or
  - (iii) to employ a person as a permitted teacher in a school,the applicant has made any statement or furnished any information which is false in any material particular or by reason of the omission of any material particular;
- the applicant is a bankrupt within the meaning of the Bankruptcy Ordinance (Cap. 6) or has entered into a voluntary arrangement under that Ordinance;
- the applicant has previously been convicted in Hong Kong or elsewhere of a criminal offence punishable with imprisonment; or
- the applicant has been registered as a manager of 5 or more schools.
